IT IS HEREBY CERTIFIED by the undersigned, who conducted the mail ballot election held by Hidden Valley Farm Metropolitan District No. 3 of Weld County, Colorado, on the 5th day of May, 2026, that, after swearing and subscribing to their oaths of office, they opened the ballot depository/walk-in voting location at 1700 Lincoln Street, Suite 2000, Denver, Colorado, at 9:00 a.m. on April 13, 2026, and kept said ballot depository/walk-in voting location open between 9:00 a.m. and 5:00 p.m. every business day through May 4, 2026 and on May 5, 2026, election day, the hours were extended from 7:00 a.m. to 7:00 p.m. for receipt of ballots and walk-in voting, after which time they counted the ballots cast for Directors of the District and for any ballot issue or ballot question submitted in accordance with the Colorado Local Government Election Code.


